The intent of this Order is to institute standards for the requirement to use Face Coverings when outside of the home or in an enclosed place of Public Accommodation, with the goal to ensure people protect themselves and others, particularly those who are vulnerable to poorer outcomes related to COVID-19 infection.

This amended order intends to ensure that Residential Living Facilities that house and treat the elderly and medically vulnerable in Long Term Care Facilities adopt the most aggressive mitigation strategies to combat the spread of COVID-19. Other facilities, which also house high risk individuals but do not provide assisted living or nursing care, such as retirement homes and communities, shall practice social distancing and other requirements as outlined to protect this less vulnerable, but still high-risk population.

- One "white goods" item (e.g. appliances and hot water heaters) may be picked up at least once per month. Residents must contact Republic Services Customer Service to request the pick-up.

• **SMALL BUSINESS RELIEF PROGRAM**

The St. Louis County Small Business Relief ("SBR") Program will provide financial relief to small businesses that were closed during the Stay at Home Order. The grant can be used to pay for the costs of business interruption as a result of the business closing during the Stay at Home Order and to cover costs associated with reopening safely.

Business interruption costs could include fixed operating costs during closure. Reopening costs could include acquiring personal protective equipment for employees or customers or installing plastic shields to reduce the risks of transmission between customers and employees.

• **ST. LOUIS COUNTY DEPARTMENT OF PUBLIC HEALTH - DIRECTOR OF PUBLIC HEALTH - EXTENSION AND AMENDMENT OF STAY AT HOME ORDER**

The intent of this order is to ensure that the maximum number of people remain in their places of residence to the maximum extent feasible, while enabling essential services to continue, to slow the spread of COVID-19 within St. Louis County. When people leave their place of residence, whether to obtain or perform essential services, or to otherwise facilitate otherwise authorized activities, they should at all times reasonably comply with Social Distancing Requirements. This order extends the effective date of the order until it is rescinded.

• **ST. LOUIS COUNTY DEPARTMENT OF PUBLIC HEALTH - DIRECTOR OF PUBLIC HEALTH - LOSS OF LIFE ORDER**

The intent of this order is to mitigate the impact of COVID-19 in St. Louis County by establishing respectful and safe procedures for funeral directors, medical transport and crematories for handling COVID-19 decedents and by authorizing the Medical Examiner of St. Louis County to direct the deposition of the remains of unclaimed decedents.

APRIL 21, 2020

• **YARD WASTE COLLECTION – RESUMPTION OF SERVICE**

Republic Services has announced that they will be resuming weekly Yard Waste service beginning Monday, May 4th. Republic will have additional trucks and drivers on the route to assist with heavy volumes. Yard Waste will be collected on the regularly schedule day.

The City will NOT be conducting another collection prior to the week of May 4, 2020.

St. Louis County - Executive Order 15 - Stay at Home Order: Executive Order issued by St. Louis County Executive Dr. Page in response to the Coronavirus (COVID-19) Pandemic; **ordering “non-essential” individuals to Stay Home has been extended until Mid-May at which time the order will be reevaluated.**

APRIL 6, 2020

• **DOG PARK AT WOODSON ROAD PARK - CLOSURE**

Effective Monday, April 06, 2020, the Dog Park at Woodson Road Park will be closed until further notice. Current memberships will be extended for a period equal to the number of days that the Dog Park is closed. The issuance of New Dog Park memberships is suspended until the Dog Park reopens.

APRIL 2, 2020

• **CITY HALL – SUSPENSION OF PUBLIC ACCESS**

- Effective immediately, City Hall will be closed to the public with the following exceptions;
- Anyone picking up and paying for permit or license.

The City has installed a drop box at the front of City Hall to allow permits and plans to be dropped off during business hours. City Staff will retrieve items dropped off during the day. Once the permit or license application has been processed, City Staff will contact the applicant advising them that their permit or license is ready to be picked up.

For those coming to pick-up and pay for a permit or license, the City has installed a remote access system on the front door. Instructions for the system are posted on the front door of City Hall.

Only **ONE (1) PERSON** will be allowed in the building at a time.

- **MUNICIPAL COURT – SUSPENSION OF PUBLIC ACCESS**

Effective immediately, the Overland Municipal Court will be closed to the public.

- **RESIDENTIAL OCCUPANCY INSPECTION – SUSPENSION OF SERVICE**

Effective immediately, the City has **SUSPENDED** the requirement that an initial inspection of the property be conducted prior to occupancy. The suspension of this requirement is effective until further notice.

Once the State of Emergency Declaration is lifted; the applicant will be required to schedule an inspection of the property.

Anyone requiring an Occupancy Permit is still required to complete and submit the appropriate application to the City, prior to occupying the premises.

- **WOODSON ROAD TENNIS COURTS - CLOSURE**

Effective immediately, the Tennis Courts at Woodson Road Park are closed to the public and will remain so until further notice. The City has installed signage adjacent to each tennis court denoting the closure.

- **ST. LOUIS COUNTY DEPARTMENT OF PUBLIC HEALTH - DIRECTOR OF PUBLIC HEALTH - RESIDENTIAL LIVING FACILITIES ORDER**

This order intends to ensure that facilities housing or treating the elderly and medically vulnerable individuals adopt aggressive mitigation strategies to combat the spread of COVID-19 among a medically vulnerable population.

MARCH 31, 2020

• **ST. LOUIS COUNTY DEPARTMENT OF PUBLIC HEALTH - DIRECTOR OF PUBLIC HEALTH - RAPID NOTIFICATION ORDER**

The intent of this order is to require reporting for test results, hospitalizations and deaths of individuals affected with COVID-19, in order for DPH to institute appropriate investigation and control measures to limit the spread of COVID-19 in St. Louis County.

MARCH 26, 2020

• **CITY PLAYGROUND - CLOSURES**

Based on a recommendation from St. Louis County, all playgrounds within the City's park system will be closed until further notice. The City has installed signage adjacent to each playground denoting the closure.

This closure does **NOT** apply to the general park property including the walking paths and trails.

• **SPRING CLEAN-UP CANCELLED**

In light of the Stay-At-Home order issued by the St. Louis County Executive, the Spring Clean-Up scheduled for April 18, 2020 has been cancelled. The event has not been rescheduled at this time.

MARCH 24, 2020

• **BULK PICK-UPS AND YARD WASTE COLLECTION - SUSPENSION OF SERVICE**

At the request of Republic Services, the City is suspending Bulk Pick-Up and Yard Waste collection effective March 30, 2020. The suspension of these services will continue until further notice. This action will enable Republic Services to place all drivers on trash/recycle routes thereby focusing all efforts on services required by all of our residents.

In addition, in an effort to keep drivers safe, Republic Services will not pick up any debris or bags outside of the carts. Therefore, trash and recycle material will be limited to cart only.

***NOTE: This action DOES NOT affect solid waste (trash) collection, which will continue to occur on its regularly scheduled day.**

• **CITY HALL – SUSPENSION OF EXTENDED HOURS ON WEDNESDAYS**

Effective immediately, the City is suspending the Extended Hours on Wednesdays. City Hall will remain open Monday thru Friday 8:00 A.M. to 5:00 P.M. The Suspension of Extended Hours on Wednesdays: will continue until further notice.

• **ST. LOUIS COUNTY DEPARTMENT OF PUBLIC HEALTH - DIRECTOR OF PUBLIC HEALTH - AMENDED QUARANTINE AND ISOLATION ORDER**

The intent of this order is to assure isolation and quarantine of identified person who have COVID-19 or have been exposed to COVID-19. Isolation and quarantine are important components of a multi-layered strategy to prevent, limit, and contain the spread of COVID-19 in St. Louis County. St. Louis County and its employees, contractors, and agents shall treat every person who is isolated or quarantined with compassion, respect, and dignity.

• **ST. LOUIS COUNTY DEPARTMENT OF PUBLIC HEALTH - DIRECTOR OF PUBLIC HEALTH - ORDER RESTRICTING THE OPERATIONS OF RESTAURANTS AND BARS**

This Order is intended to limit the spread of COVID-19 in St. Louis County to protect the public health by imposing limited and temporary restrictions on the use and operation of restaurants and bars. This Order requires all restaurants and bars to provide all food and beverage service through only delivery service, window service, walk-up service, curbside service, drive-through service, or drive-up service and prohibits in-person dining or drinking on the premises of restaurants and bars.

The Planning and Zoning Commission Meeting scheduled for March 30, 2020 has been cancelled.

The intent of this order is to ensure that the maximum number of people remain in their places of residence to the maximum extent feasible, while enabling essential services to continue, to slow the spread of COVID-19 within St. Louis County. When people leave

their place of residence, whether to obtain or perform essential services, or to otherwise facilitate otherwise authorized activities, they should at all times reasonably comply with Social Distancing Requirements.

MARCH 21, 2020

- **ST. LOUIS COUNTY - EXECUTIVE ORDER 15 - STAY AT HOME ORDER**

Executive Order issued by St. Louis County Executive Dr. Page in response to the Coronavirus (COVID-19) Pandemic; ordering “non-essential” individuals to Stay Home.

MARCH 19, 2020

- **ST. LOUIS COUNTY DEPARTMENT OF PUBLIC HEALTH - DIRECTOR OF PUBLIC HEALTH - ORDER PROHIBITING CERTAIN INTENTIONAL GATHERINGS**

This order is designed to prevent the entrance of an infectious, contagious, communicable, or dangerous disease into St. Louis County and to limit the spread of such disease within St. Louis County.

MARCH 18, 2020

- **STATE OF MISSOURI – EXECUTIVE ORDER 20-03**

Executive Order issued by Governor Parsons in response to the Coronavirus (COVID-19) Pandemic; delaying Municipal Elections in the State of Missouri until June 2, 2020.

- **DEPARTMENT OF COMMUNITY DEVELOPMENT – CLOSURE TO PUBLIC**

As of March 18, 2020, public access to the Department of Community Development will be prohibited. All department business will be conducted through the Administration Department, located on the main floor of City Hall.

The Department remains fully staffed and the City will continue to accept, and process applications and conduct the associated inspections. In addition, the City will continue to work with those who require review and approvals of the Planning and Zoning Commission and the Board of Adjustment.

*NOTE: Those who call for an inspection are being advised that only one (1) person may be present in the residence at the time of the inspection, in an effort to reduce potential exposures and adhere to recommended standards for social distancing.

Anyone having business with the Department of Community Development is encouraged to communicate with the Department via telephone at (314) 428-4677, to the maximum extent possible, until such time as the suspension of public access has been lifted.

- **SENIOR UTILITY REBATE PROGRAM SUSPENSION**

The City is suspending the acceptance of applications for the Senior Utility Rebate Program effective Wednesday, March 18, 2020. This is to encourage those eligible for the program to remain at home for their own health and well-being.

The acceptance of applications for the Senior Utility Rebate Program will be reinstated at a date to be determined.

- **SOLICITOR PERMITS SUSPENSION**

The City is suspending the issuance of solicitor permits effective Wednesday, March 18, 2020. This suspension of this service shall be effective until further notice.

- **ST. LOUIS COUNTY - EXECUTIVE ORDER 14 - INTENTIONAL GATHERINGS (NO MORE THAN 10)**

Executive Order issued by St. Louis County Executive Dr. Page in response to the Coronavirus (COVID-19) Pandemic; limiting intentional gathers to no more than ten (10) people in a single space.

MARCH 17, 2020

- **OVERLAND MUNICIPAL COURT – ORDER OF THE PRESIDING JUDGE - COURT SESSION CANCELLATION**

Amended Order issued by Presiding Judge Christopher B. Graville (Overland Municipal Court);

• **YARD WASTE COLLECTION – SUSPENSION OF SERVICE**

At the request of Republic Services, the City is suspending yard waste collection effective Tuesday, March 17, 2020. The suspension of yard waste collection will continue through Friday, March 27, 2020. Yard waste collection will resume the week of Monday, March 30, 2020. This action will enable Republic Services to place all drivers on trash/recycle routes thereby focusing all efforts on services required by all of our residents.

***NOTE: This action DOES NOT affect solid waste (trash) collection, which will continue to occur on its regularly scheduled day.**

• **ST. LOUIS COUNTY - EXECUTIVE ORDER 13 - BARS AND RESTAURANTS**

MARCH 16, 2020

• **OVERLAND COMMUNITY CENTER - CLOSURE**

The Overland Community has decided to close the Overland Community Center beginning at 5:00 P.M. on March 16, 2020. The Overland Community Center will remain closed until further notice.

During the closure, City Staff will be cleaning and sanitizing the facility in anticipation of its reopening.
