**VIOLATIONS BUREAU SCHEDULE OF OFFENSES AND FINES**  
EFFECTIVE SEPTEMBER 2, 2008

Pursuant to the Missouri Statute 479.050, Rule 37.49 of the Supreme Court Rules of the State of Missouri and Section 130.100 of the Code of the City of Overland, the undersigned Municipal Judges of the City of Overland hereby order that the following designated offenses shall be payable to the City of Overland Violations Bureau. In such cases, no court appearance is necessary.

Any third offense within a two-year period of a moving violation, and any violation resulting in personal injury or property damage may not be paid through the Violations Bureau.

Court Costs shall be in addition to the fine.

\*\* No Proof of Insurance summons where the defendant brings in proof that he/she had insurance on the vehicle on the date of the summons, the case will be Nolle Prossed by the prosecutor. If the defendant brings in proof he/she has procured at least three (3) months of insurance on the car since the summons was issued (with one month paid in advance), the prosecutor will amend the summons to a no-point violation upon payment of the scheduled fine and costs.

\*\*\* Expired Operators License (If proof of renewal is shown to clerk within 30 days of expiration, the summons shall be dismissed upon payment of court costs in the amount of \$12.00)
