Please provide **TWO (2) COPIES** of the following items;

- Scaled site plan indicating location of proposed driveway, any existing driveway to remain, house, accessory structures, property lines, swimming pool (if applicable), etc. **Plat drawings are not acceptable.** A land surveyor's sealed site plans may be requested upon review of plans.
- Scaled construction plans are required. All plans must be drawn in a professional manner and contain all required information.

MAINTENANCE REQUIREMENTS:

Residential driveways and parking areas must be maintained in good repair and free of safety hazards. Surface coating for residential use shall not be less than two (2") inches of asphalt or four (4") inches of concrete installed over a four (4") inch compacted rock base. Driveways and parking areas in residential areas shall not exceed twenty (20) feet in width extending from the street to the building. Impervious surfaces are calculated into lot coverage total. Lot coverage may not exceed 40% of the total lot area.

NOTICE TO APPLICANT

By signing this application, the applicant affirms that as legal owner of the property in question or as the agent to whom permission has been granted by the legal property owner of record, that all information contained hereon is accurate and true. The applicant also grants the City of Overland, Missouri authority to enter onto this property to conduct all inspections allowed by law during reasonable hours. Additionally, the applicant agrees to ensure that all aspects of this project shall conform to all applicable laws, codes and ordinances. Failure to comply shall cause the revocation of this permit.

1. **Two (2) copies** of a site plan are required to be submitted with your construction plans. Plat drawings are not acceptable. A land surveyor's sealed site plans may be requested upon review of plans.
2. **Two (2) copies** of scaled construction plans are required. All plans must be drawn in a professional manner and contain all required information.
3. All applications must be fully completed and signed as required. Failure to provide all required information will cause a delay in the review process.
4. A valid state issued photo ID is required with all applications.
5. Required inspections will be specified when permit is issued.
6. Please allow seven (7) to ten (10) business days to review process to be completed.
7. All inspections must be scheduled at least **Forty-Eight (48) hours** in advance.

Normal inspection fees are included in the above schedule of building permit fees, however, where, in the judgment of the Building Commissioner, additional inspections are required and/or where inspections are called for by the contractor, but the work is found not ready for inspection and/or where the work fails to pass inspection and a re-inspection is required, then an additional ten dollars (\$10.00) per such inspection will be made and must be paid before an occupancy permit is issued.
